Notes to the Financial Information

1. DESCRIPTION OF BUSINESS

McCauley Community League (the "League") is an Edmonton based non-profit organization incorporated under the Societies Act of Alberta on November 9, 1982. As a non-profit society the organization is exempt from income taxes.

The League is a member of the Edmonton Federation of Community Leagues ("EFCL") and offers a variety of community-based programs with a view to promote recreational and cultural activities for citizens in the McCauley neighborhood.

2. BASIS OF ACCOUNTING

The financial information is comprised of a statement of financial position, statement of operations and statement of unrestricted net assets and certain accompanying notes where management believes the additional notes provide information helpful to understanding the financial information. The financial information has been prepared on the accrual basis of accounting with selected accounting estimates regarding the useful lives of property and equipment.

The financial information excludes certain information normally included in a full set of financial statements prepared in accordance with generally accepted accounting standards.

3. RESTRICTED CASH

Restricted cash is comprised of amounts which are restricted for future expenditures. The balance amounts in the casino account of \$60,283 (2020 - \$4,306) as well as restricted cash within the general account of \$25,000 (2020 - \$38,220).
